

Nova Buduchnist Student Bursary Application Form

To be eligible for the BCU Nova Buduchnist Student Bursary, students must submit a completed BCU Nova Buduchnist Bursary Application with all applicable attachments by the posted deadline, must be members of the Credit Union through the Nova Buduchnist Benefit Program, and provide documentation which indicates financial need. In addition, they must also demonstrate how they are integrating into the Ukrainian-Canadian community and reflecting BCU Financial's values and guiding principles through volunteerism.

- **Previous year's Notice of Assessment or applicable financial documents, banking statements, and signed net worth statement indicating need for financial assistance.** Additional financial information pertaining to the applicants and/or parents/legal guardians may be requested to assess financial need.

All qualifying applicants will be considered for the scholarships. BCU Financial Scholarship and Student Bursary Program is an anonymous process. All applications are reviewed and considered by the BCU FSC which consists of a BCU Financial Board Member who acts as Chair, representatives of Ukrainian Youth Association of Canada CYM, Ukrainian Youth Association Plast, IOUC Fourth Wave, Ukrainian Canadian Students' Union SUSK, and representatives from the Academic and Business spheres. Applications do not contain applicants' names or any personally identifying information. Only complete applications received by BCU Financial Scholarship Committee will be considered.
